DESCRIPTION:

This course examines the role of public sector in the economy. The aim of the course is to provide an understanding of the reasons for government intervention in the economy, the extent of that intervention and the response of private agents to government actions. It will in particular focus on design of tax systems and benefit schemes and the mechanisms of social insurance.

READINGS:

The text for the course is "Public Finance and Public Policy" by Jonathan Gruber, Second Edition, Worth Publishers 2007. This book is not available in the bookstore. You can get a copy from the library and I will put the necessary chapters to the photocopy room. This book mainly focuses on the US economy therefore you are not responsible from US economy parts but I will post additional documents on Turkish Fiscal system and public policy.

GRADING INFORMATION (PROBLEM SETS AND EXAMS):

The course grades will be based on a midterm (25%), a final exam (<u>cumulative</u>) (50%), 4 problem sets (20%, 5% each), attendance and participation (5%). We will have recitation hours in this class, in the recitation hours your TA will solve the problem sets and answer your questions. There will not have recitation hours every week. Recitation hours will be announced in METU online by your TA.

All exams are closed book. I will use the class web page to distribute problem sets and solutions, sample exams, solutions and other announcements. Problem sets will be posted on Wednesdays and I will post the answers online next Wednesday. Meanwhile you can ask me questions. Problem sets it is really important to solve them on time and check the answers and ask the questions you did wrong. Similar questions might be in the midterm or final. (Usually I do not ask the same questions)

Before each exam I will hold extra office hours. If you still have questions do not hesitate to contact me (come to my office hours or email, please give me at least 12 hours to respond)

There is a very simple key for getting a good grade and learning the material well.

Please follow the steps below:

- a) There will be assigned readings. The reading assignments usually come from the textbook if not I will definitely post it online. Always read the relevant chapter and extra readings assigned before coming to the class. You will definitely understand the material better and enjoy the class more that way. Remember it is a matter of timing, instead of reading after the class you will read them before the class and be more successful.
- b) Class participation is very important. Always ask questions. There is nothing like a stupid question. I promise to answer any questions you have related to the class even though I mentioned it before.
- c) Never miss the classes if you don't have a reasonable excuse. Although the classes will be based on the textbook, I might mention ideas or include materials that are not necessarily in the textbook.
- d) Always go over the chapters and class notes regularly. If you leave it the day before the exam even the simplest concepts might seem impossible to understand. Try to sleep well before the exam such that you might have room to use your creativity.
- e) After each exam, I might be willing to talk with the students with grades very much below the average. Don't take it personal; I will not be doing that to punish you. I have been a student so long to know that everything does not necessarily go well each time.

Always come to these meetings, we can talk together and figure out a way to help you. I will not announce these students in the class. I will set appointments by email.

I will use the student's mailing list to distribute important announcements and room changes. Try to check your mails everyday!

Collaboration on problem sets is permitted. (You should not copy the answers from your friend you can never be sure that she/ he is not mistaken) Collaboration during midterms and the final exam is strictly prohibited.
