MSCA Objective

Ensure the optimum development and dynamic use of Europe's intellectual capital in order to generate new skills, knowledge and innovation

Budget 2014-2020: €6 162 million

- €745 million in 2015 for all calls together
- €756,5 million in 2016 for all calls together
- €839,5 million in 2017 for all calls together

MSCA Key features

- Open to all domains of research and innovation from basic research up to market take-up and innovation services (**bottom-up**);
- Open to all **nationalities** (individual researchers);
- Participation of **non-academic sector** strongly encouraged, especially industry and SMEs; The collaboration between **academia and non-academia** encouraged as well;
- **Mobility** as the key requirement - funding on condition participants move from one country to another;
- Promotion of **attractive** working and employment conditions;
- Particular attention to **gender balance**;

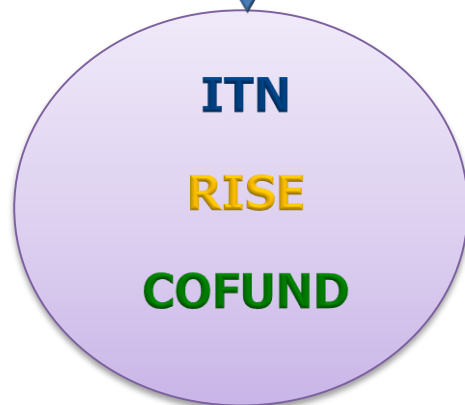

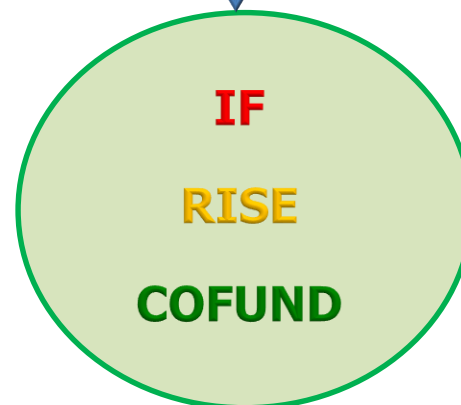

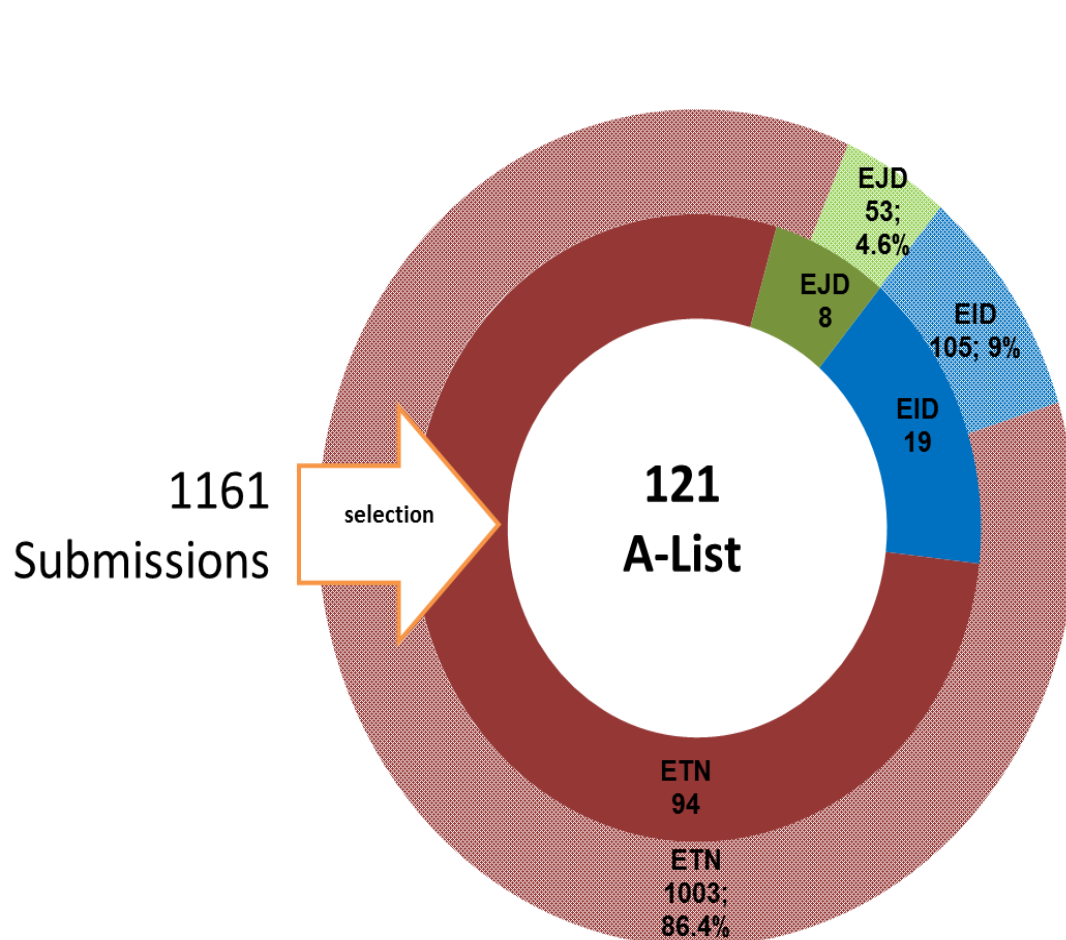
- ✓ **Raise excellence** and **structure research and doctoral training**

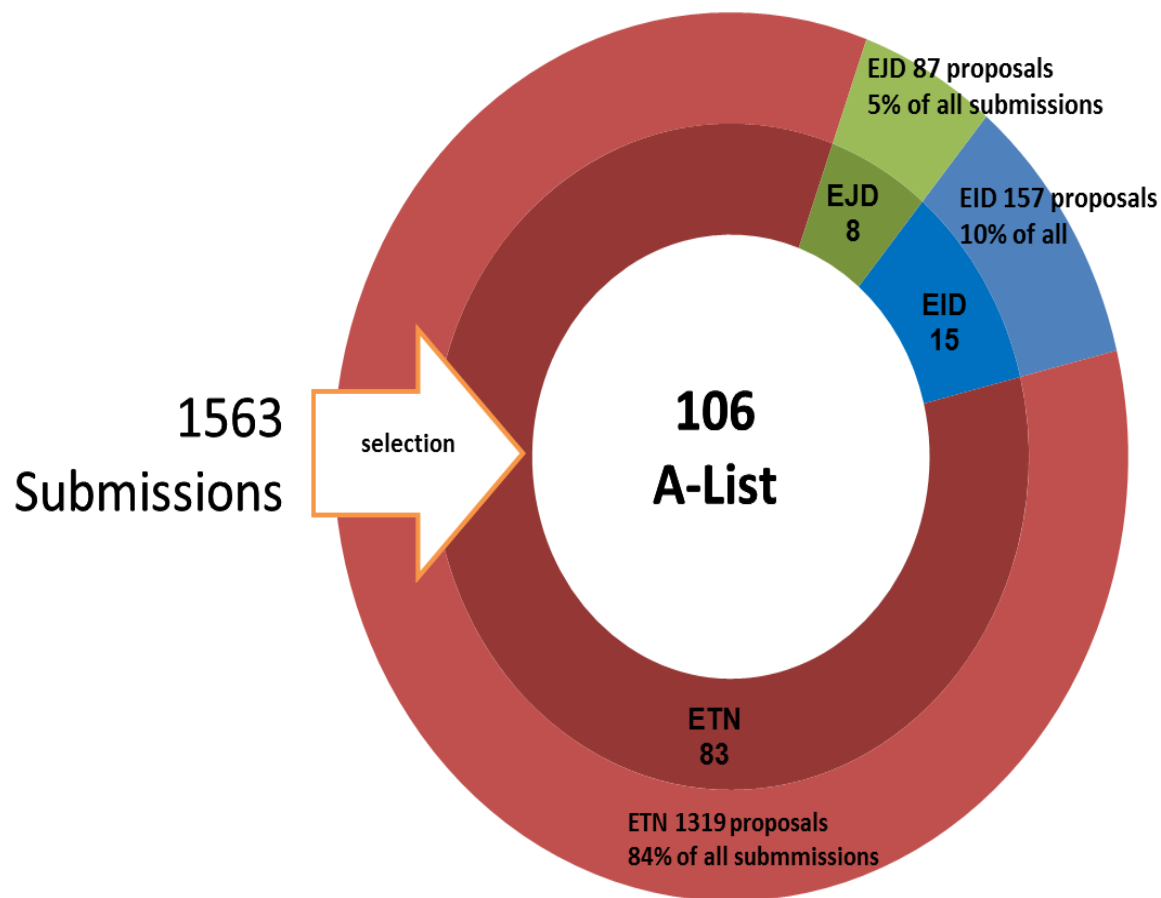

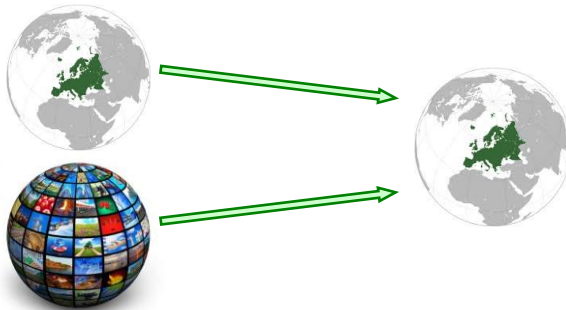
- ✓ Enhance the creative and innovative potential of **experienced researchers**

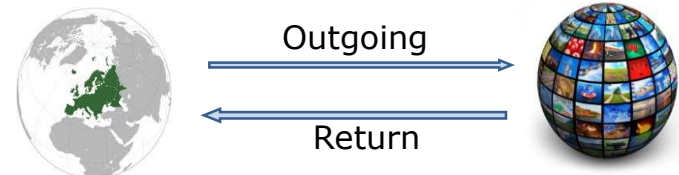

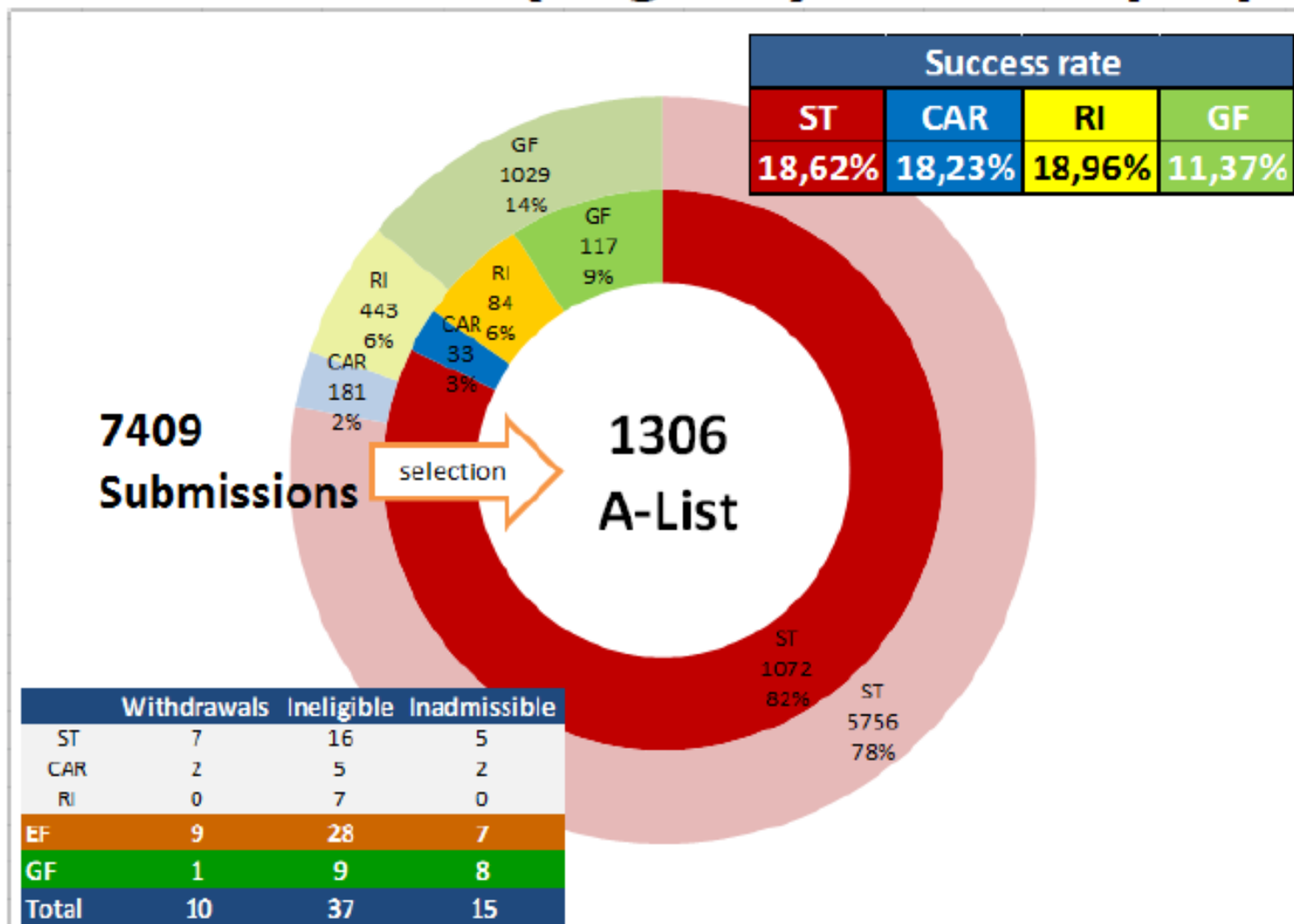

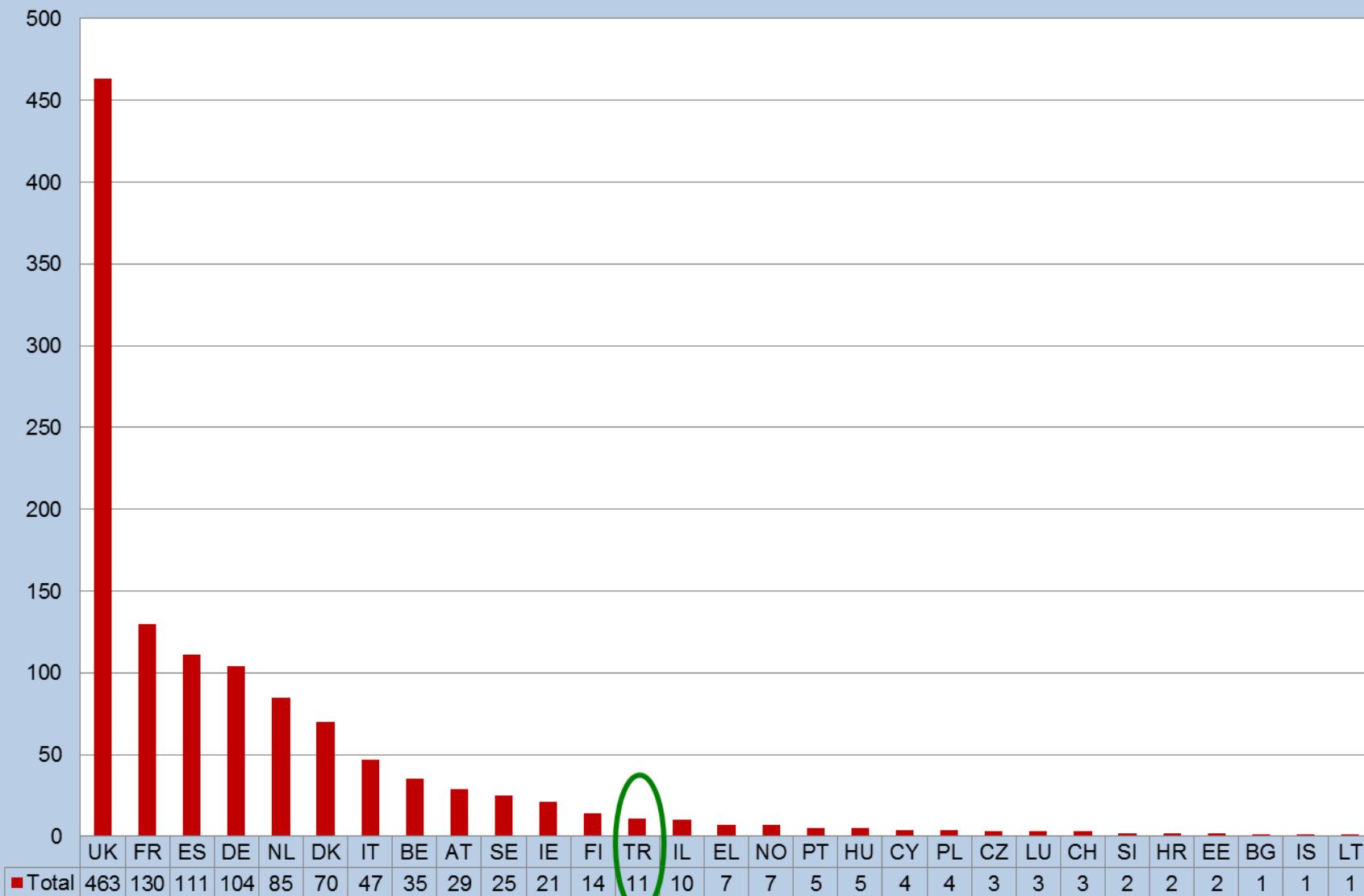
IF 2014: Submitted (eligible) & A-list proposals

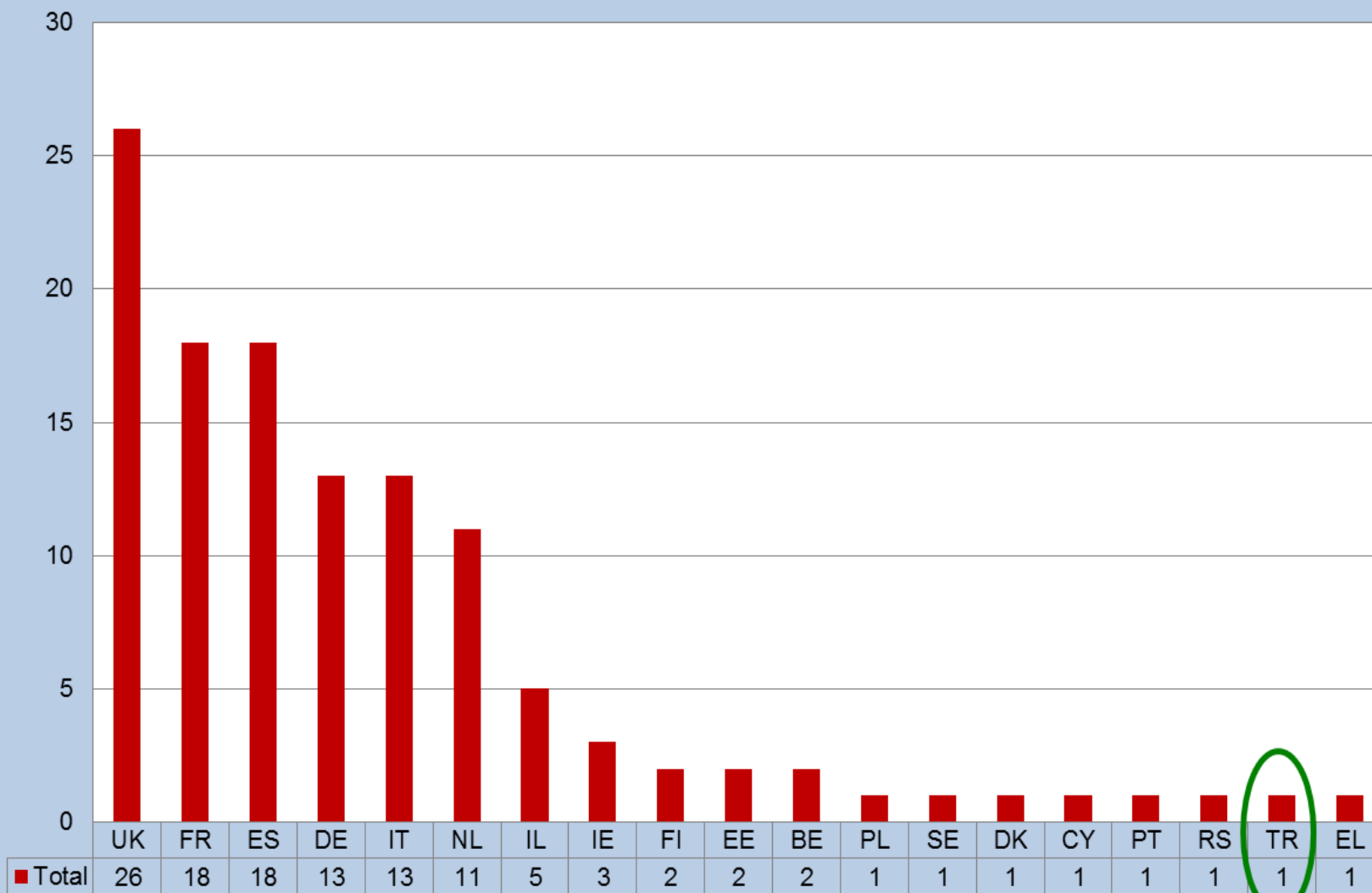
IF-EF 2014

IF-GF 2014 (return phase)

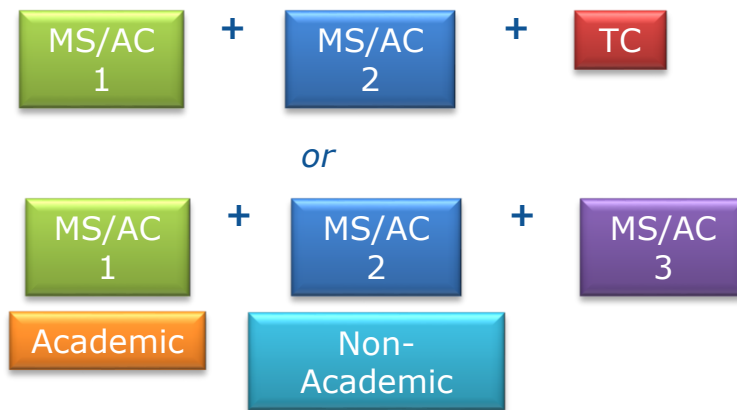

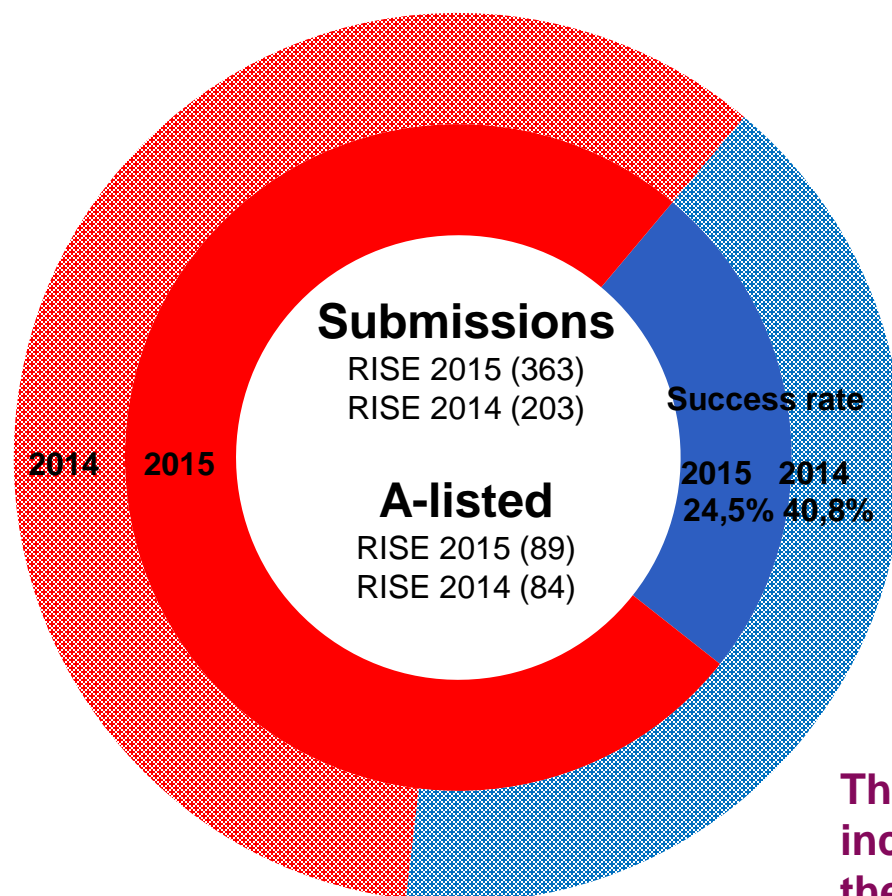

Research and Innovation Staff Exchange (RISE)

- ✓ Strengthen the interaction between academic and non-academic organisations, and between Europe and third countries, through **research and innovation staff** exchanges
- ✓ International and inter-sector **transfer of knowledge** and sharing of ideas and of R&I culture
- ✓ Common **research and innovation project**
- ✓ Highly skilled research and innovation staff **move for 1-12 months**
- ✓ Minimum consortium:



RISE 2015 compared to RISE 2014: Submitted & A-list proposals



The submission in 2015 increased which reduced the success rate by half



COFUND

- ✓ Promote **international, intersectoral and interdisciplinary research training**, as well as transnational and cross-sector **mobility** of researchers at all stages of their career by **co-funding new or existing regional, national, and international programmes**
- ✓ Mono-beneficiary: **organisation funding or managing doctoral or post-doctoral programmes**
- ✓ **Leverage funding** and combat fragmentation (possible synergies with ESIF)
- ✓ **Spread MSCA best practices**

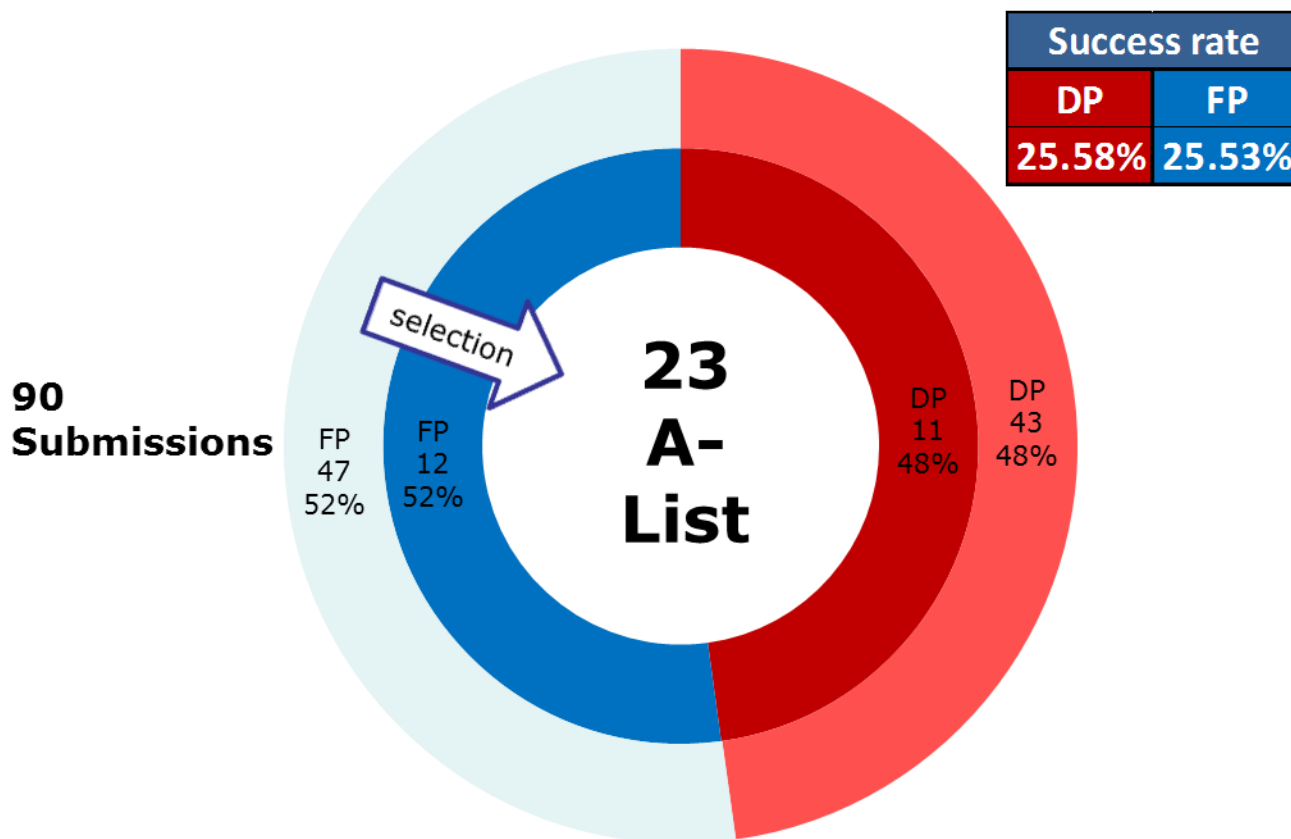

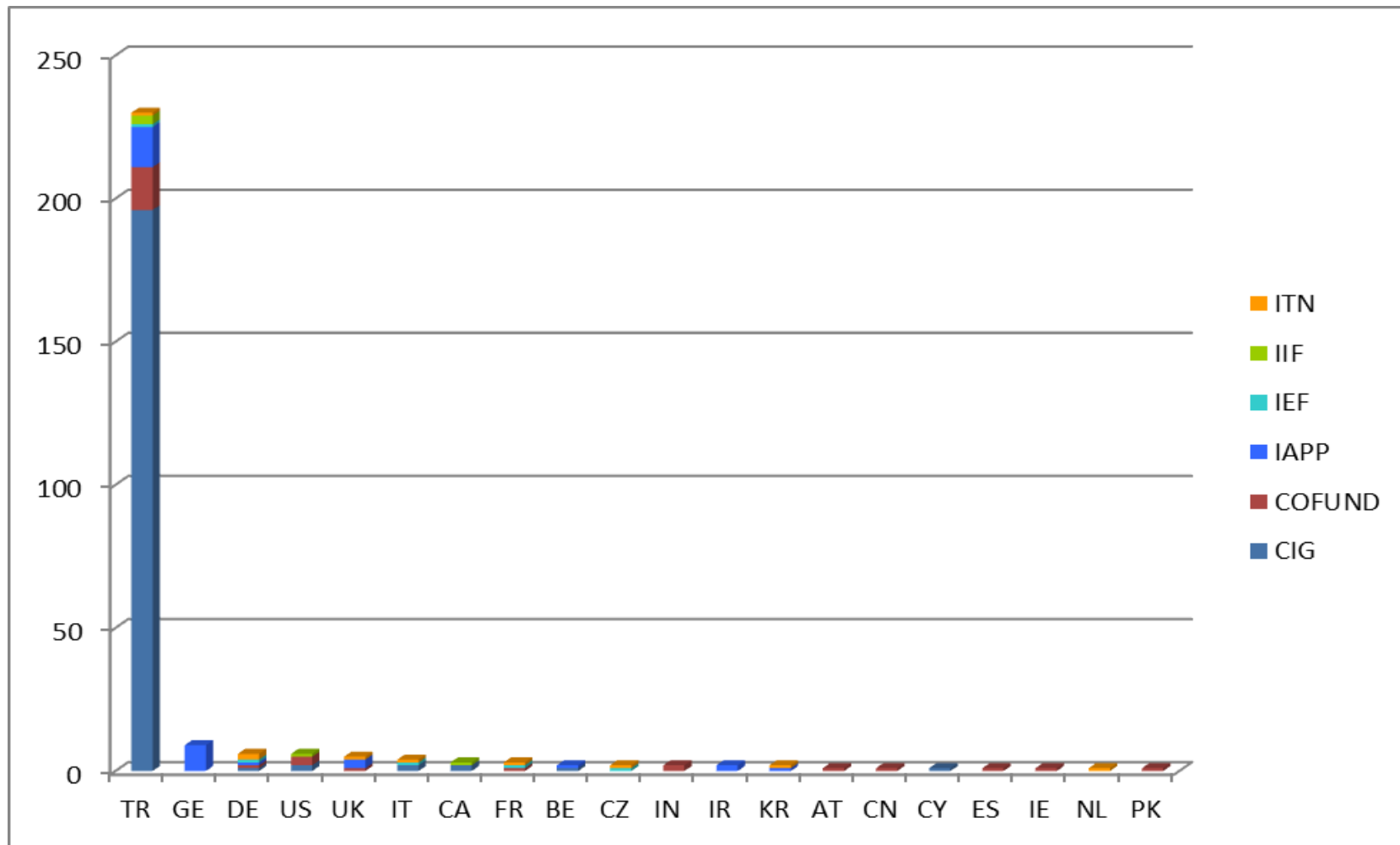
Turkey Participation in FP7 Marie Curie Actions

Key figures (last update 07/2015):

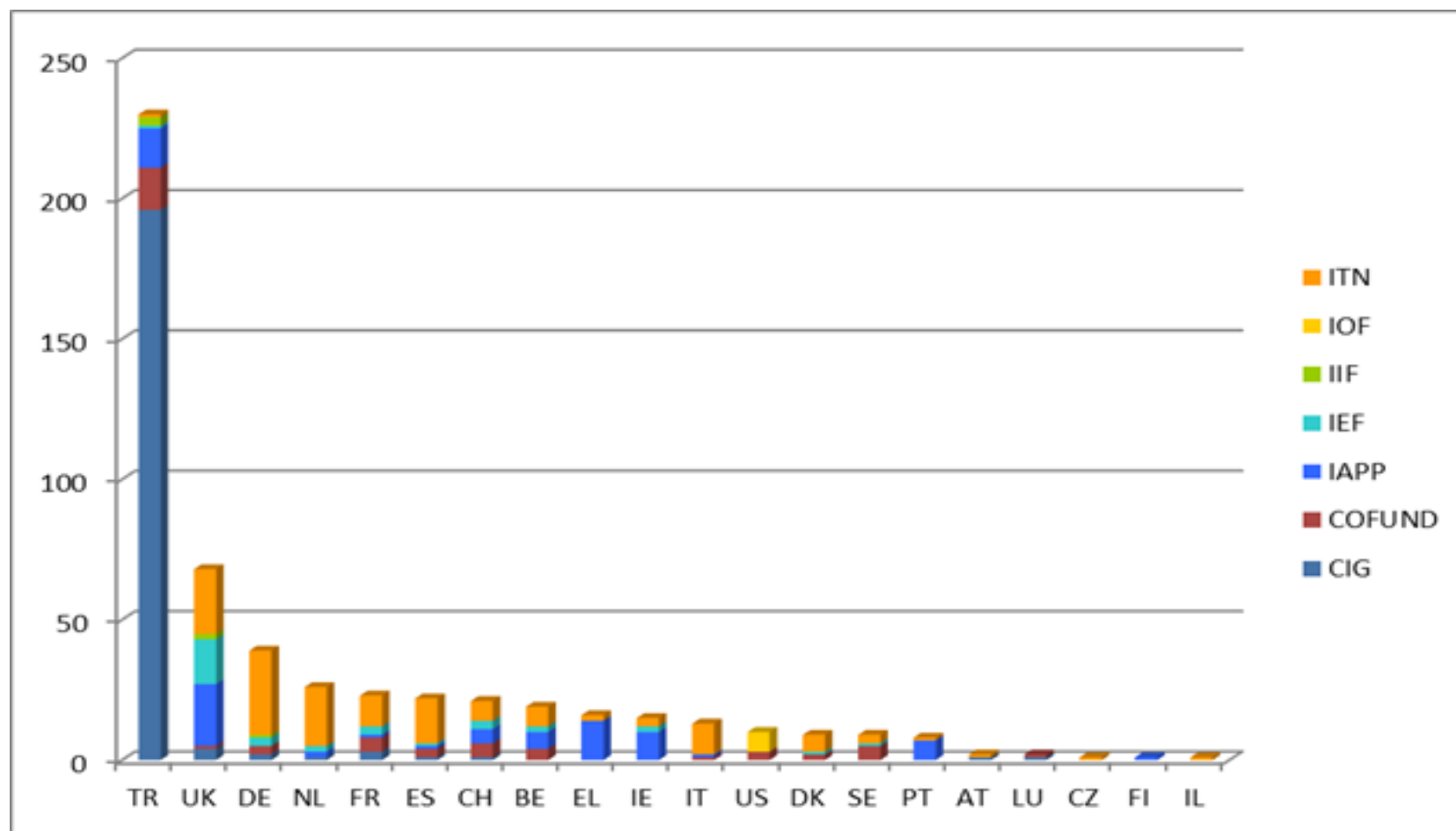
- 750 Turkish Researchers Funded;
- € 37,1 Million awarded to Turkish organisations;
- 308 participations from Turkish organisations (90% universities) 211/308 participated in the **Career Integration Grants** scheme (94% universities);
- **Top 5 participations from Turkey (Higher Education)**
